This Agreement, made this _____ day of _____, 20____ between _____, hereinafter known as Client and TIG Investigative Services, hereinafter known as "Agency," witness:

(1) Client retains Agency for the collection of evidence in the matter of _____

(2) Client agrees that Agency is empowered to perform said services for and on behalf of Client, and to do all things necessary, appropriate, or advisable in performing said services.

(3) Agency agrees to conduct this investigation with due diligence to protect the interests of Client, and agrees that whatever confidential information is obtained while conducting the investigation will only be given to Client.

(4) Client agrees to pay a **REFUNDABLE RETAINER**, less any expenses, charges reflective of services of Agency or his Agents the sum of **\$1,000.00**, the hourly rate shall be **\$ 95.00 per hour**, plus **\$.55 per mile**, plus actual costs and expenses for each Agent authorized by Agency to work on his behalf. **Number of Agents authorized for this case** _____. The hourly rate plus costs and expenses will be deducted from the retainer. All Services are to be paid for by retainer in advance.

(5) Client and Agency agree to a **flat rate of \$**_____ for this service.

(6) In the event that Client requests suspension or termination of the services of Agency, it is agreed by Client that all monies paid to Agency shall remain the property of Agency, and any balance owing on the retainer fee, together with any accrued expenses plus costs of the investigation, shall become due and payable in full. Any balance not used by client will be refunded after a final invoice is completed within 10 business days of written cancellation.

(7) Client agrees to pay to Agency the sum of \$95.00/hour or any portion thereof for any time spent in court at the request of the Client due to this investigation. Said amount will be paid regardless of the fact that it may entail waiting or standby time.

(8) It is agreed that Agency has made no guarantee to Client as to the results regarding the above-stated matter. Agency only guarantees that the case will be worked in a timely fashion and as economically as possible.

(9) Client further agrees that all monies owed to Agency at the completion of this investigation will be paid in full at that time; either by bank draft, wire transfer or credit card payment prior to any reports are issued. All monies not paid in full as agreed will be subject to a one and one-half percent (1-1/2 %) interest charge per month or any portion thereof for each and every month the balance remains unpaid. Client further agrees to pay all costs of collection plus reasonable attorney fees.

(10) All reports/photos/video furnished to Client by Agency are for the information of Client only. Client agrees to hold Agency harmless from any and all damages, which are occasioned by any disclosure of any part of said reports.
